The Republic of Moldova (hereinafter called “Borrower”) has received financing from the European Investment Bank and European Bank for Reconstruction and Development (all together - the “Banks”) in the form of a loan, financing and grant (hereinafter called financing) toward the cost of Moldova Energy Efficiency Project. The Moldova Energy Projects Implementation Unit, an implementing agency of the Borrower, intends to apply a portion of the proceeds of this financing to eligible payments under the contract for which this Request for Proposals is issued.

MEPIU now invites proposals to provide the following consulting services (hereinafter called “Services”): *Elaboration of the detailed technical design and author supervision for energy efficient rehabilitation of Neurology and Neurosurgery Institute (Lot 1), Republican Medical Diagnostic Centre/Physiopneumology Institute (Lot 2), Cardiology Institute (Lot 3) and Psychiatry Clinical Hospital (Lot 4).*
3. This Request for Proposals (RFP) has been issued without prior short-listing procedure and is open to all interested participants.

A firm will be selected under “Quality and Cost Based Selection” (QCBS) procedures and in a Full Technical Proposal (FTP) format as described in this RFP, in accordance with the policies detailed in the EIB’s Guide to Procurement version of 2018, which can be found at the following website: <https://www.eib.org/en/publications/guide-to-procurement>.
